Minutes of Meetings held on Tuesday 1st October, 2013

Pre Meeting : Fireworks Event, Tuesday November 5th, 2013

Prior to the main meeting, Stadhampton Parish Council met with the Fireworks Committee to discuss the 2013 Fireworks event. The main points arising were :-

Confirmation that, if possible, the bonfire will be constructed on the day itself (although it was agreed that it is highly unlikely that this can be achieved given the fact that people are now used to leaving combustibles well in advance of the event - a tradition built up over many years).

That the Clerk will post SODC 'no fly-tipping' signs in the hope that non-combustible items (sofas, mattresses, tyres, paint etc.) will not be 'dumped'.

That non-combustible items will have to be separately removed by BIFFA at the cost of the fireworks committee (the Parish Council had to bear the cost of doing this last year as the Fireworks Committee declared that they had made a loss for the 2012 event).

That the fireworks committee have responsibility for repairing damage to the green caused by the bonfire and by car parking (a major problem in 2012 due to a long period of rain / soft ground).

That the Clerk will investigate to see if the Parish Council insurance policy can be amended to include future fireworks events.

That Cllr. Pete Smith will attend planning meetings on behalf of the PC (and that Cllr. Melissa Parkes will fill in if Pete is unavailable). Pete and Melissa also offered their help as volunteers on the day of the event.

That Sue White will inform the local police of organisations or individuals who have permission to attend the event.

The Fireworks Committee presented Income and expenditure accounts for the period 2001 to 2012. A surplus of £6,193 (which has been built up over a number of years) will be carried forward to the 2013 event. The Parish Council will forward the accounts to the internal auditor and agreed to purchase the 2013 fireworks so that the VAT can be reclaimed.

092/13	Report from Oxfordshire County Council (OCC)	<p>Cllr. Lorraine Lindsay-Gale (LLG) sent apologies for absence but forwarded a report as follows:-</p> <p><u>Home to School transport</u> The next consultation will open on 4/11/13 and close on 20/12/13. It will be advertised widely to give everyone the opportunity to respond. It will be promoted directly to all state funded schools in the county, through the OCC web portal, local newspapers, social media and various press releases.</p> <p><u>Park & Ride Charges</u> Due to budgetary pressures charges at Thornhill and Water Eaton will be introduced in November bringing them into line with the City Council. Parking will still be free for the first hour and Blue Badge holders will be exempt.</p> <p><u>City Deal</u> An Oxfordshire Strategic Housing Market assessment will take place to assess the scale of housing needed for the period up to 2031, including both market and affordable housing. The interim report concludes that there is a requirement for 48,500 homes, equivalent to 2,425 homes per year. The report highlights a significantly increased need in Oxford City and West Oxfordshire.</p> <p>It may be that the City will not be able to accommodate its housing needs within its own boundaries in a sustainable way but the prospect is still for large scale housing development at Grenoble Road, between Sandford, Blackbird Leys and Garsington.
