006/12	Report from Oxfordshire County Council (OCC)	County Councillor Lorraine Lindsay-Gale reported as follows :- 1) that the proposals for the future of the library service were considered on December 12th, 2011. The decision of the Cabinet was to approve a revised plan that will see 43 libraries remain open. 22 will remain staffed by the County Council; 4 will be 'Community Plus' libraries (2/3 paid staff, 1/3 volunteers); the remainder will be 'Community' libraries (1/2 paid staff, 1/2 volunteers). 2) that OCC has given its support to the Government decision to approve funding for a new East-West rail link between Oxford and Bedford via Bicester, Aylesbury & Milton Keynes. 3) that OCC is opposed to the HS2 high-speed rail link and is arguing that the finance should be spent on the existing rail network instead. 4) that there has been a huge response to the OCC Minerals and Waste Plan Consultation which highlighted Cholsey as the South Oxon. site for future gravel extraction (being nearest to the centres of demand and having limited flood risk). See agenda item 012/12. 5) that the Local Government Boundary Commission has now reached its draft recommendations regarding the Parliamentary review of MPs constituencies and has proposed a reduction of eleven County Councillors to 63 representing 59 single-member divisions and 2 two-member divisions. 007/12	Community Building Project (CBP)	<p>The Community Building Project committee made an excellent presentation to SPC on 7/11/11. The project will cost an estimated £350,000. There followed a letter from the CBP committee requesting a £15,000 development grant required for architects and set up fees.</p> <p>This request was backed up by numerous letters of support sent to SPC. The majority of residents present at the meeting were supportive too. However, it is to be minuted that although it is hoped that this grant will help to secure other funding (for example, BIFFA, WREN), there is no guarantee of this.</p> <p>SPC voted to agree the request for the £15,000 development grant, 50% available with immediate effect and the remaining 50% upon the signature by both parties of an agreement governing how the money may be spent. Proposed by MM, seconded by LE.</p> <p>It was explained that (and why) SPC is unable to reclaim the VAT on architects fees incurred by the CBP committee which is independent both in terms of governance and finance.</p> <p>LLG noted her support for the project and suggested that the CBP committee submit a grant application to the Big Society fund.</p>	<p>For info.</p> <p>Decision</p> <p>For info.</p> <p>LLG</p>
